Dear Parade Participant:

The City of Fruitland Park will hold its annual Fruitland Park Days celebration on March 30 & 31, 2012. The Annual Parade will be on **Saturday, March 31 at 10 AM**. The City would like to *invite your group to participate* in this event that attracts visitors from all over the state to our old-time, yet friendly city. There is **NO ENTRY FEE** for this parade.

The parade line-up will begin at 8:30 AM in the vacant field on Shiloh Street across from Cales Recreation Complex. We are asking that all participants entering the city for this parade use the intersection of Dixie Avenue/CR 25A and US Hwy 27/441 to access the line-up area. This will aid us in alleviating traffic during this busy day in our city. The parade route and line-up points are shown on the map included in this packet. Please make copies of this map for all participants! You will receive a call or email from the Recreation Office by March 23 to let you know what number you will be in the parade. We suggest putting this number on copies of the map and make sure all participants with your group know what NUMBER they need to look for when they arrive. All participants are required to complete the entire route from the start at Cales Park to the dispersal point at Fruitland Park Elementary School.

The **deadline for parade applications is Friday March 16, 2012**. The City of Fruitland Park must receive all forms and waivers no later than this date to guarantee your entry into our parade. The City cannot guarantee any spots for forms and waivers received by the City after this date, regardless of postmark. Therefore, please return forms and waivers in a timely manner as this is imperative for the proper planning of the procession. Please be sure to fill out application forms as completely as possible, and *ensure that all signatures are in place on waivers* where required. Trophies are awarded for winners at the Judges table at the conclusion of the parade.

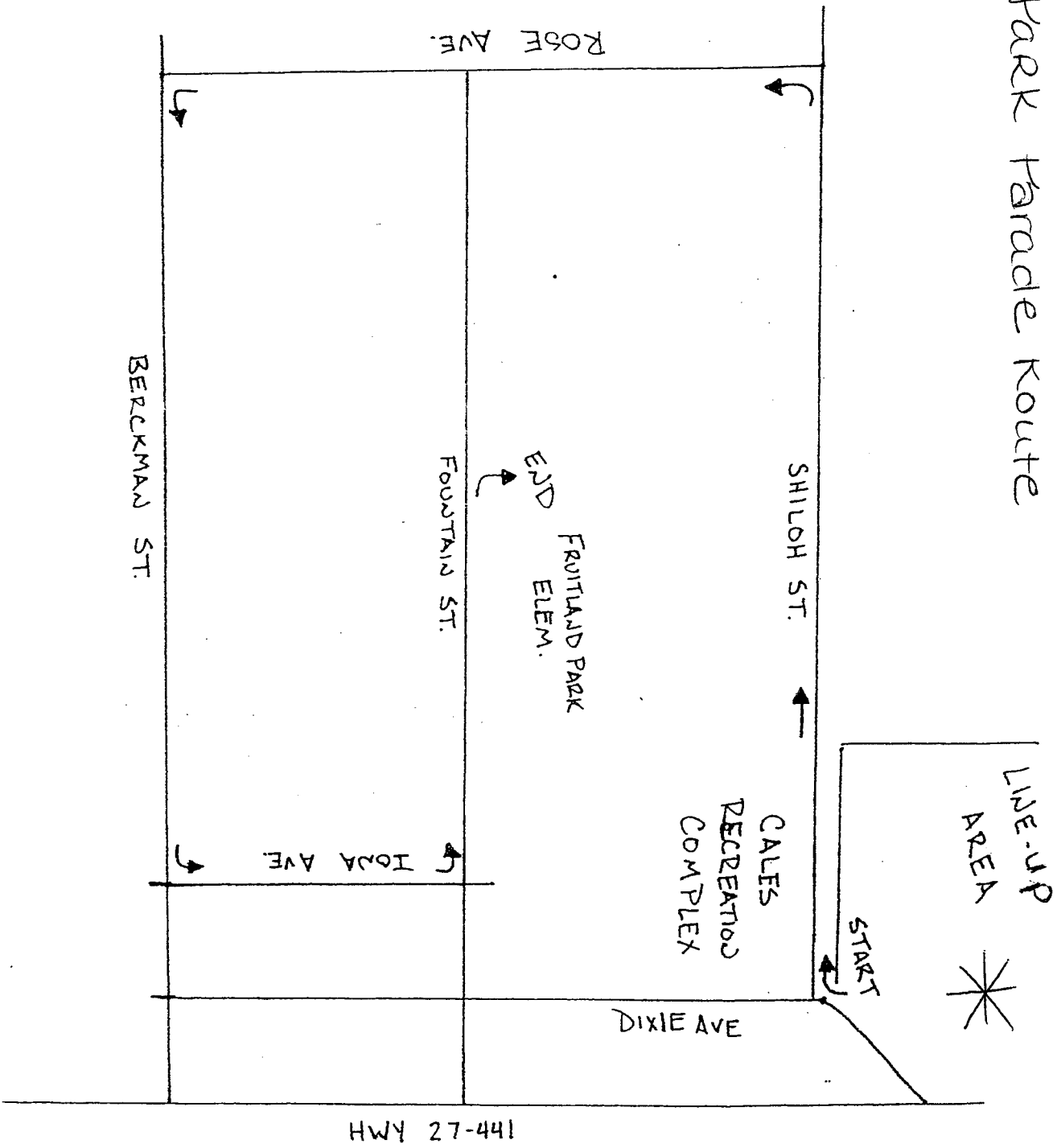

In further consideration of the acceptance of my application for other good and valuable consideration, receipt of which is hereby acknowledged, I both for myself and my heirs, executors, personal representatives, administrators, and assigns, agree to indemnify and hold harmless the City of Fruitland Park and its officials, employees, agents, representatives, successors, and assigns for all liabilities, claims, actions, damages, costs or expenses, including attorney's fees, assessed against them arising out of or in any way connected with my participation in the Fruitland Park Day's event, including travel and transportation to or from any event or activity connected therewith, and including personal or bodily injuries, wrongful death or property damage which may be suffered by me or others before, during, or after participation in the Fruitland Park Day's event. I understand that this release, waiver, and indemnification includes, but is not limited to, any claims based on gross negligence, negligence, action or inaction of any of the above parties, and includes, but is not limited to personal injury, bodily injury, wrongful death and property damage. I further understand that this release waiver and indemnification is intended to be as broad and inclusive as permitted by the laws of the State of Florida.

The undersigned has read and voluntarily signs this release waiver and indemnification of liability and further agrees that no oral representations, statements or inducements, apart from the foregoing written agreement have been made.
