Subject: Date of Retirement Distribution

Per Statute 175.361, "the board of trustees shall determine the date of distribution" for the firefighters' pension payout. The Actuary will need four weeks after the board selects the payout date to calculate the termination valuation for the firefighters. The firefighters will receive their pensions on the date selected for the payout.

The board should select a date at least 60 to 90 days out to allow time to process the payouts and also allow for delays in calculations. The earliest date should not be before September 27, 2021. The board needs to select a date, make a motion on the date, and vote to confirm the date. The city treasurer will then pass the information to the actuary and the pension payout process will begin.
