Ashley's House & Cottage Honoring 1st LT Ashley White's Ultimate Sacrifice

1st LT Ashley White was killed during combat operations in Kandahar Province, Afghanistan on Oct. 22, 2011 when the assault force she was supporting triggered an improvised explosive device. Ashley was assigned to the 230th Brigade Support Battalion, 30th Heavy Brigade Combat Team, North Carolina National Guard, Goldsboro, NC and served as a member of a Cultural Support Team attached to a Joint Special Operations Task Force Afghanistan. As a Cultural Support Team Member on her first deployment to Afghanistan, White selflessly served. Ashley's actions exemplify the highest commitment to duty, honor, and country. In every instance she served with distinction in support of the Task Force and our great nation.

Ashley was born on Sept.3, 1987 to parents Robert and Deborah White. Ashley is survived by Robert, Deborah, her twin sister Brittany, brother Josh and husband CPT Jason Stumpf. Ashley was a graduate of Arlington H.S. (2005) and Kent State University (2009). Ashley is remembered not simply as an exemplary soldier but as the best daughter, sister, wife and friend anyone could hope to have.

Ashley was commissioned in the U.S. Army as a Medical Service Corps Officer after her graduation from Kent State University. Her awards and decorations include the Parachutists Badge, The Ohio Faithful Service Ribbon, the armed Forces Reserve Medal, the Army reserve Achievement Medal and the National Defense Service Medal. Ashley was posthumously awarded the Bronze Star, the Purple Heart, the Meritorious Service Medal, the Afghanistan Campaign Medal, and the Combat Action Badge.

Ashley inspired all those around her and it is the hope of her family and friends that her life will continue to inspire.

Villagers For Veterans is honored to name The New Beginnings Women Veterans Transition Homes in Central Florida after 1st LT Ashley White. Her memory will serve to inspire the many women veterans as they transition into successful civilian lives.

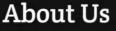

After discussion and by unanimous consent, the city commission directed staff to proceed with the request for proposals for auditor services prior to the FY 2023-24 budget process for city commission consideration on a future agenda.

After Mr. Rankin described the subject proposed Ordinance 2023-001; conveyed the January 19, 2023 Planning and Zoning Board's recommendation of approval and relayed staff's recommendation for the applicant to submit a conceptual plan with a rezoning to Multi-Family Medium Density Residential (R-10) and an adequate school determination or school concurrency reservation which was provided and confirmed that the subject project meets the minimum standards of the city's code.

After Vice Mayor DeGrave questioned the Fruitland Park Apartments revised site plan (included in the February 9, 2023 regular meeting agenda), and after Mr. Logan J. Opsahl, Lowndes et.al, Attorney representing the applicant, gave a power-point presentation on Kimaya LLC's Annexation, Small-Scale, Comprehensive Plan Amendment and Rezoning where he indicated that the site (conceptual) plan ought to have been included, Ms. Coulson confirmed in response to Mayor Cheshire's question that it together with the presentation was not provided prior to this evening's meeting. (A copy of the presentation is filed with the supplemental papers to the minutes of this meeting.)

After discussion and in response to several questions posed, Messrs. Opsahl and Mr. Charles "Chuck" C. Hiott, Halff Associates, Inc. (consultants retained by the city) addressed their willingness to provide in advance visual renderings displaying the proposed residential parcels.

Mr. Hiott described the current conceptual plan with surrounding uses; the design of rented two-story town homes and three-story buildings which he claimed -- in response to Commissioner DeGrave's inquiries that was not received by the commission -- was previously provided to the community development staff, and confirmed that no garages are on the apartment site; thus, greenspaces to the south includes stormwater retention, landscape buffers, and between the buildings as well as ingress and egress.

After the city commission voiced concerns -- on the lack of recreational amenities, parking garage, the reduction of the northern section from 15 to ten units per acre (proposed development previously owned by Holloway Properties Inc.) annexation of which is between multi-family units and single-family properties; the focus on the multitude of "upscale, high-end, luxury" residential properties, and greenspaces reserved for stormwater retention and landscape buffer -- and requested an improved conceptual plan, Mr. Opsahl addressed the opportunity to meet with the elected officials to review same.

Later in the meeting, Mr. Carl Yauk, The Villages of Fruitland Park (Pine Hills resident), commended the city commission on its anticipated actions.

ACTION: 6:31:31 p.m. After discussion, Commissioner Mobilian proffered a motion to continue proposed Ordinance 2023-001 to a future meeting.

In response to Mr. Opsahl's statements and following the Ms. Geraci-Carver's advice, a motion was made by Commissioner Mobilian and seconded by Commissioner Gunter that the city commission deny Ordinance 2023-001 as previously cited.

Dear Mr. Dicus,

Wright-Pierce would like to thank the City of Fruitland Park (City) for the opportunity to submit this proposal to provide professional engineering services for water main design on County Road (CR) 446A, Phase 3B.

Project Background/Understanding

Lake County, using the engineering services of Kimley Horn, has prepared construction documents for the reconstruction and widening of CR 466A Phase 3B. The project roadway limits are from 2,640 feet west of Josephine Drive to 348 feet east of Poinsettia Avenue for a total length of approximately 6,258 linear feet. The project involves widening the pavement from 2 lanes to 4 lanes, adding curb and gutter, a center median, a substantially altered roadway profile, and a new enclosed stormwater collection and conveyance system. The roadway and drainage improvements are located within existing or new right of way (minimum widths vary from 94-ft to 114-ft) and roadway grading will occur outside these limits in permanent easements. The County expects to begin construction in the summer of 2023.

Fruitland Park owns and maintains water mains within the roadway project limits and the proposed roadway and drainage work will require the City to relocate the water mains. Per the City, approximately 1,000 linear feet of water main is in place at both the west and east ends of the project and they are in alignment with the proposed roadway work and do not need to be relocated. The remaining 4,200 linear feet in the middle of the project contains existing mains or no mains at all. The City's objective is to have a contiguous 12-inch diameter water within the project limits. This will require the relocation of segments of existing water mains, new water mains in segments that currently lack water service, fire hydrants at a maximum of 500-ft intervals, reconnection to existing water mains at Janice Drive, Valley Road, and Cutoff Road, extension stub-outs to the north for future development, and reconnection of approximately 25 existing metered service connections.

Under our Continuing Services Agreement, the City has asked Wright-Pierce to provide a Task Order Proposal for the design of the stated water main improvements. The Scope of Work shall include the design of the water main improvements, surveying needed to support the design efforts, preparation of FDEP water main extension permit applications, coordination and communication with Lake County and their engineering consultant for design coordination, right-of-way permitting, coordination and communication with applicable

regulatory agencies and other utility owners/providers, development of an engineer's opinion of probable construction costs, preparation of bid documents and specifications for incorporation into Lake County's bid process, representation on the City's behalf during the bidding process, and construction administration. To accomplish the City's obligations and objectives, Wright-Pierce proposes the following Scope of Work, Schedule, and Compensation.

Scope of Work

Task 1 – Project Initiation, Project Management, and Administration

1.1 This task will consist of overall management of the project, invoicing, scheduling and general coordination with the City, Lake County, and other stakeholders.

1.2 Wright-Pierce will hold a kick-off meeting with the City within 7 calendar days of the Notice to Proceed (NTP). We expect this meeting to be attended by the City, Lake County, Lake County's roadway design engineer, and other utility providers/owners located within the project limits.

1.3 We will submit monthly status reports of the project progress with each invoice.

1.4 We will conduct bi-weekly project status meetings with the design team and key City staff. It is assumed the project will take 5 months to design, resulting in 10 project status meetings.

Task 1 Deliverables:

Wright-Pierce will provide the City with PDFs of the following:

- Kickoff meeting agenda and minutes (PDFs).
- Monthly status reports and/or meeting minutes (PDFs).

Task 2 – Data Collection

2.1 Wright-Pierce will require the latest electronic files of the roadway project from Lake County to serve as the existing conditions for our design efforts. These MicroStation-based design files will be converted to AutoCAD for use as base mapping for our subsequent work.

2.2 The current roadway plans do not accurately reflect the position of the City's water mains. Therefore, we will contract with Echo UES, Inc. to perform additional topographic surveying. The surveying work will include locating all visible above ground water appurtenances, verifying the existing conditions shown in the roadway plans, and updating base mapping.

2.3 Subsurface Utility Evaluations (SUE) will be performed by Echo UES, Inc. to better determine the locations of the existing water mains. SUE will be performed in two parts. Part 1 will consist of Utility Quality Level C and D. Level D is based on record drawing requests and reviews and Level C is based on the field surveys and other field observations. Wright Pierce will contact the City, Sunshine 811, and other known utility owners and request copies of their utility plans. These records will be represented in our updated base mapping.

Part 2 will consist of Utility Quality Level A which is based on the horizontal and vertical locating of utilities at a specific point using minimally invasive vacuum test holes (soft-digs). Part 1 work will be performed during the initial data collection phase of work. Part 2 will be deferred until after the 50% design efforts have been completed so the soft-digs can be targeted to areas of most concern. We expect soft-digs to be performed at the proposed water main tie-in points at the east and west ends of the project and at the connection points at Janice Drive, Valley Road, and Cutoff Road. For budgeting purposes, 10 test holes are included in this Scope of Work. Note that Quality Level A SUE is not proposed for other utilities within the project since it is expected that they will be relocated as part of the CR 466A widening.

2.4 Wright-Pierce will require copies of the geotechnical investigation report obtained/used by Lake County for the roadway project for use in our designs and contract document preparation.

Task 2 Deliverables:

No separate deliverables are associated with this task. The results of the surveying and SUE will be incorporated into the design plans.

Task 3 – Design

3.1 After obtaining and reviewing the project data and assembling AutoCAD base mapping Wright-Pierce will proceed with design efforts and plan development. This will include detailing the horizontal and vertical alignment of water mains to be relocated, delineating the extent of water utilities to be removed, and preparing construction details. Since Lake County plans to start construction in the summer of 2023, an expedited design schedule will be required. Therefore, we propose 50%, 90%, and Final design phases, and virtual design review meetings will be held with the City for each of these design phases. We anticipate the following construction drawings will be prepared for each phase:

3.2 Wright-Pierce will coordinate our design efforts with other private utility owners preparing their own relocation plans. We expect to participate in up to 2 virtual coordination meetings during the design process.

3.3 We will develop an Opinion of Probable Construction Costs for the proposed design.

3.4 We will prepare Contract Documents and Technical Specifications in 16 Division, CSI format. We expect these documents to include typical Division 1 contract documents, and applicable Division 2 site-related technical specifications. Florida Department of Transportation specifications will be referenced where appropriate. We expect Lake County to provide their Division 0 contract documents and we will incorporate them into our overall contract documents.

THIS GRANT OF A PERMANENT UNDERGROUND UTILITY EASEMENT, made this _____ day of _____, 2023, by CITY OF FRUITLAND PARK, a Florida municipal corporation, created under the laws of the State of Florida, 506 W. Berkman St., Fruitland Park, FL 34731 hereinafter called the Grantor, to and in favor of the CITY OF LEESBURG, a Florida municipal corporation, created under the laws of the State of Florida, _501 West Meadow St. Leesburg, Florida 34748 ______, hereinafter called the Grantee.

1. <u>Background</u>. Grantor is the owner of certain real property situate in Lake County, Florida, more particularly described in **Exhibit** "A" attached hereto and made a part hereof by this reference (the "Property").

Grantor is constructing a new public works building on the Property and desires electric service from Grantee. Grantee desires to provide electric service to the Grantor and requires a perpetual, non-exclusive easement under, over and across a portion of the Property which is more particularly described and depicted in **Exhibit "B"** attached hereto and made a part hereof by this reference (the "Utility Easement Property") 10+/- feet wide consisting of _____5,247.14______SF for utility purposes with full authority to enter upon construct, operate, repair, replace and maintain underground electrical lines and a transformer, and all other related and appurtenant facilities over, under, through and across the Utility Easement Property. Grantor is willing to grant Grantee an easement for said purpose, subject to the terms and conditions set forth below.

2. <u>Grant of Easement</u>. In consideration of the covenants and obligations set forth herein and other good and valuable consideration in the sum of Ten and No/100 Dollars (\$10.00) paid by Grantee to Grantor, the receipt of which is hereby acknowledged, Grantor hereby grants, conveys and declares unto Grantee, its successors and assigns, a perpetual, non-exclusive utility easement including rights under, over, through and across the Utility Easement Property, for the purpose of the construction, operation, repair and maintenance of underground electrical lines, a transformer and all other related and appurtenance facilities (the "Facilities").

The Temporary Construction Easement shall expire upon completion of construction of the Facilities within the Utility Easement Property.</u>**

7. <u>Covenants with the Land</u>. All rights, privileges, benefits and burdens created herein are covenants running with the land, binding upon and inuring to the benefit of Grantor, Grantee and their respective assigns and successors in title.

8. <u>Title</u>. Grantor does hereby covenant that Grantor is lawfully seized and possessed of the Utility Easement Property subject to no mortgages or encumbrances, and that it has good and lawful right to convey said easement without the joinder and consent of any third party.

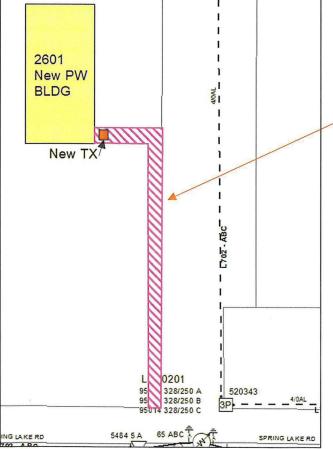

(Reference Pages 23-25, 53-55)

D. CURRENT TRANSFORMER INSTALLATIONS

- 1. The use of current transformers shall be determined by the City of Leesburg Electric Department. Three phase services over 200 amps will be CT'd, while single phase services over 320 amps will be CT'd.
- 2. It is very important to both the City of Leesburg Electric Department and the customer that the instructions and construction details shown in **Figures 18-20** be followed closely on all instrument transformer installations.
- 3. The facilities necessary for current transformer installations shall be provided and installed as described below:
 - a. The customer shall provide and install all inter-connecting raceways or conduits. All such conduits or raceways shall be a minimum of 1 ¹/₂" in diameter and a maximum of 30 feet in total length unless otherwise approved by the meter department. For installations entirely or partially below ground, 1 ¹/₂" inch minimum schedule 40 PVC conduit shall be used. For installations entirely above ground, 1 ¹/₂" minimum schedule 40 PVC or metallic Conduit may be used.

- b. The current transformers and enclosures:
 - i. The customer shall provide and install the enclosure for the current transformers. The enclosure shall be 36"x36x12" for three phase installations, and 24"x24"x12" for Single phase installations.
 - ii. The Electric Department shall provide the meter enclosure and current transformers and shall install the instruments. See Figure 24 for instructions on picking up any metering equipment supplied by the City.
 - iii. Customer must provide 3/4 plywood backing in Current Transformer cabinets per **Figures 18-19**.
 - iv. All current transformer cabinets shall have a lockable hasp. This hasp must be capable of locking with a round lock.
- c. The Electric Department shall provide and install the current Transformer secondary wiring and meter.
- d. The Customer shall not terminate nor splice his conductors within the CT enclosure.
- 4. Instrument transformer installations are usually made by one of three means, each of which requires coordination between the Customer and the City of Leesburg Electric Department.
 - a. Outdoor current transformer enclosures are normally used when the customer receives either overhead or underground service. See **Figures 18 and 19**.
 - b. Existing services, which have wall mounted or riser mounted overhead current transformer cabinets shall continue to be serviced. Additions to existing services shall be permitted, but when services are totally rebuilt, they shall be converted to outdoor wall mounted CT enclosures. When additions are made to existing services, contact an Electric Service Planner with the Electric Department for installation requirements.
 - c. Instrument transformer installations in transformer vaults and pad mounted transformers are applicable only where the number and size of secondary conductors are too many or too large to place in City of Leesburg current transformers inside wall mounted CT cabinets.

- 5. A clear space at least 48" from the front of all instrument transformer enclosures shall be maintained from grade to 6'6" height, minimum of 36" wide (18" on each side of center line of meter socket) to allow easy and safe access for reading and testing. This will be enforced on all existing and new installations.
- 6. Procedure to pick up meter can for CT installations and schedule installation of CT's
 - a. Present warehouse personnel with electrical permit and work order number provided by a Service Planner. The warehouse is located at 2010 Griffin Road, Leesburg. Warehouse hours are from 7:00 am to 3:30 pm.
 - b. Request proper meter can (Single phase CT'd is an 8 terminal, Three phase Ct'd is a 13 terminal Meter can).
 - Call the meter department at 352-728-9883 a minimum of 72 hours in advance to schedule installation of Current Transformers
- All new current installations will be wall mounted, unless prior approval is gained through the Service Planners and the Meter Department. Please consult the table below for maximum number of conductors per wall mounted CT installation.

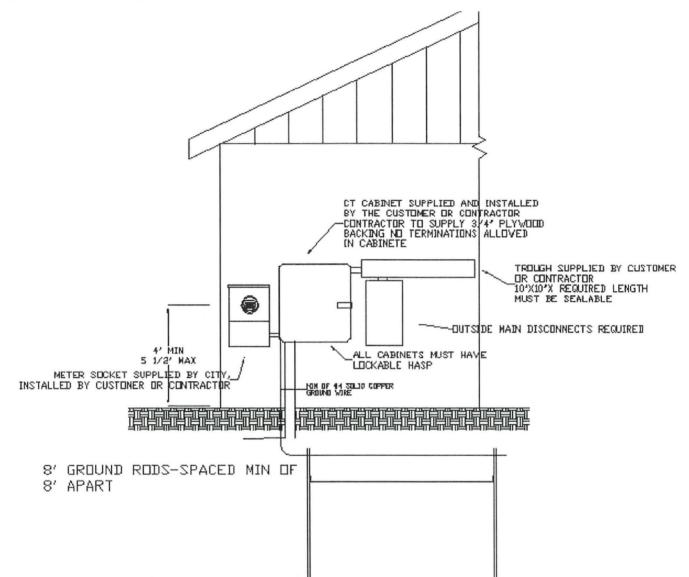

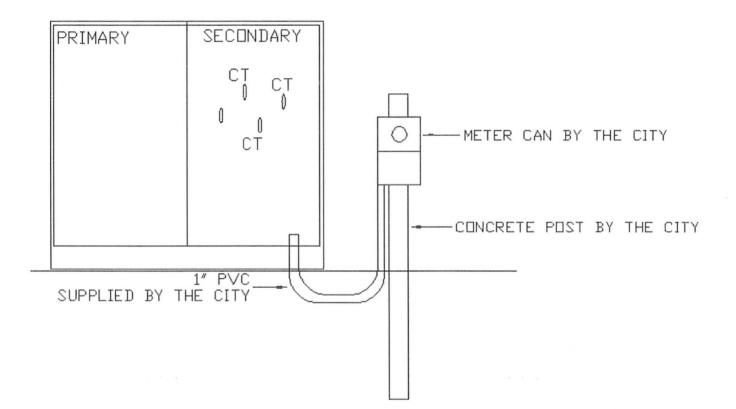

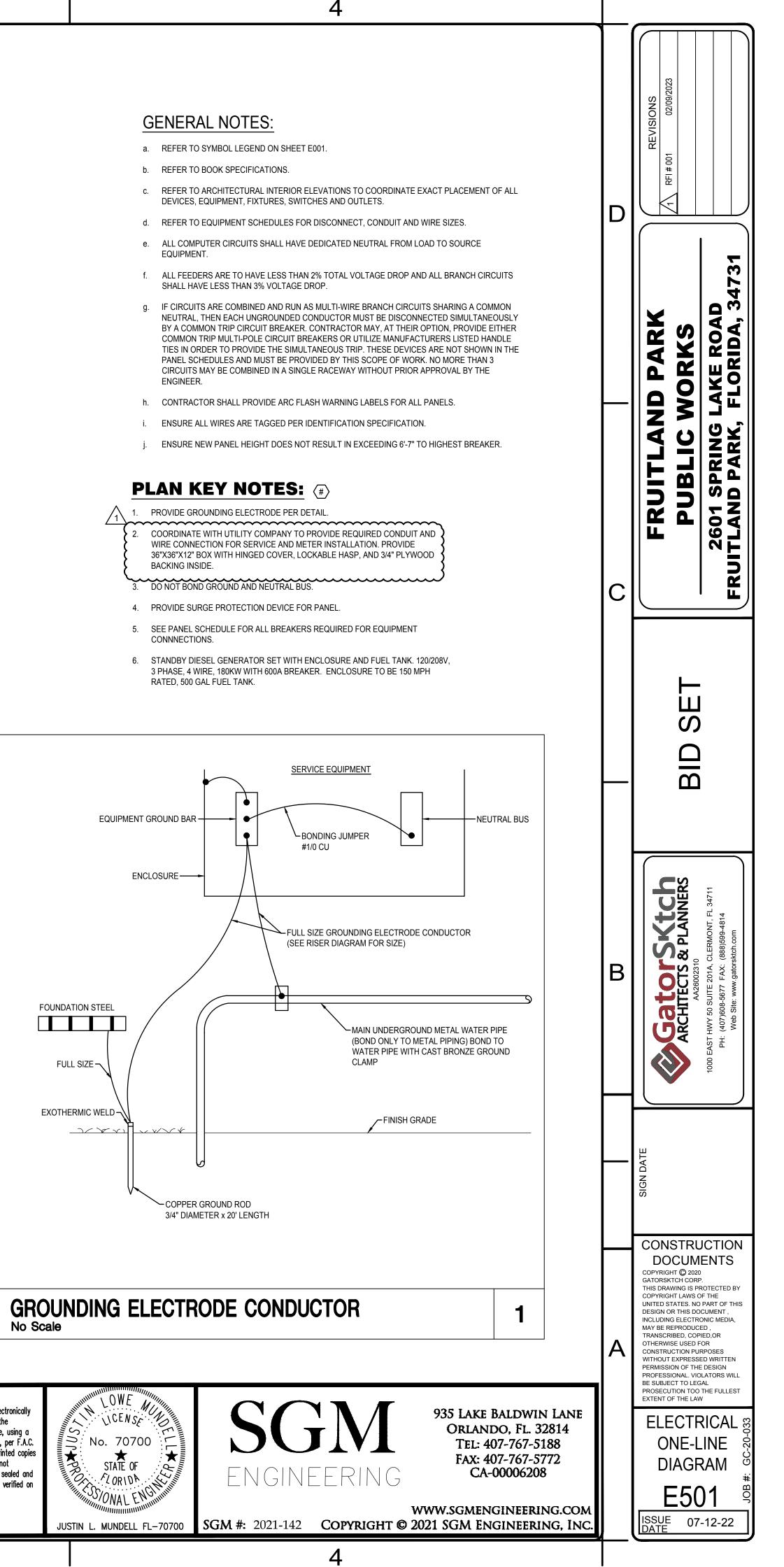

BRIEF NARRATIVE: Resolution 2023-022 – The city awarded and entered into a EJCDC Standard Form of Agreement (ITB 2022-01) with GSB Construction and Development Inc. on October 13, 2022.

This is a deductive change order for the city's new public works building located at 2601 Spring Lake Road, Fruitland Park, Florida. Change order #2 reduces the contract price with GSB Construction by \$8,000.00 due to changing the overhead cast iron sanitary pipe to Sch. 40 PVC pipe and changing overhead copper domestic water pipe to CPVC pipe.

The public works director requested this change as a cost savings to the city. Staff is of the opinion that the PVC pipe will last longer as it is resistant to chemicals and the CPVC water pipe will do the same job as the copper water pipe. Both products are almost standard products in the industry on commercial projects and represents cost savings to both the copper and cast iron that was specified.

A wet system keeps water on the entire system at all times while the dry system involves the system being maintained under air pressure at all times while releasing water to the system under a loss of pressure on the system.

Staff's communications with the contractor and his discussion with his subcontractor confirm that there is no increased maintenance cost from one system to the other.

WHEREAS, a petition has been submitted by Vishaal Gupta, as Applicant, on behalf of Kimaya, LLC, Owner, requesting that approximately $19.10 \pm acres$ of real property generally located south of Urick Street and west of Thomas Avenue (the "Property") be annexed to and made a part of the City of Fruitland Park; and

WHEREAS, the petition bears the signature of all applicable parties; and

WHEREAS, this Ordinance has been advertised as required by law with a copy of said notice sent via certified mail to the Board of County Commissioners of Lake County as provided for by statute; and

NOW, THEREFORE, BE IT ORDAINED by the City Commission of the City of Fruitland Park, Florida, as follows:

Section 1. The recitals set forth above are hereby adopted as legislative findings of the City Commission of the City of Fruitland Park.

Section 2. The following described property consisting of approximately 19.10 acres of land generally located south of Urick Street and west of Thomas Avenue, contiguous to the City limits, is hereby incorporated into and made part of the City of Fruitland Park Florida. The property is more particularly described as follows:

Section 3. Upon this Ordinance becoming effective, the property annexed shall be subject to all laws, ordinances, and regulations enforced in the City of Fruitland Park, and shall be entitled to the same privileges and benefits as other parts of the City of Fruitland Park upon the effective date of the annexation. Except that the property annexed in this Ordinance is subject to the Land Use Plan

of the Lake County Comprehensive Plan and county zoning regulations until the City adopts the Comprehensive Plan Amendments to include the property annexed in the City Comprehensive Plan.

Section 4. The City Clerk shall forward a certified copy of this Ordinance to the Clerk of the Circuit Court, the County Manager of Lake County, Florida, and the Department of State of Florida within seven (7) days after its passage on second and final reading. It shall further be submitted to the Office of Economic and Demographic Research within 30 days of approval along with a statement specifying the population census effect and the affected land area. F.S. 171.091, Florida Statutes.

Section 5. Scrivener's errors in the legal description may be corrected without a public hearing or at public meeting, by re-recording the original ordinance or a certified copy of the ordinance and attaching the correct legal description.

Section 6. If any provision or portion of this Ordinance is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portions of this Ordinance shall remain in full force and effect.

Section 7. All ordinances and parts of ordinances to the extent in conflict with this Ordinance are hereby repealed.

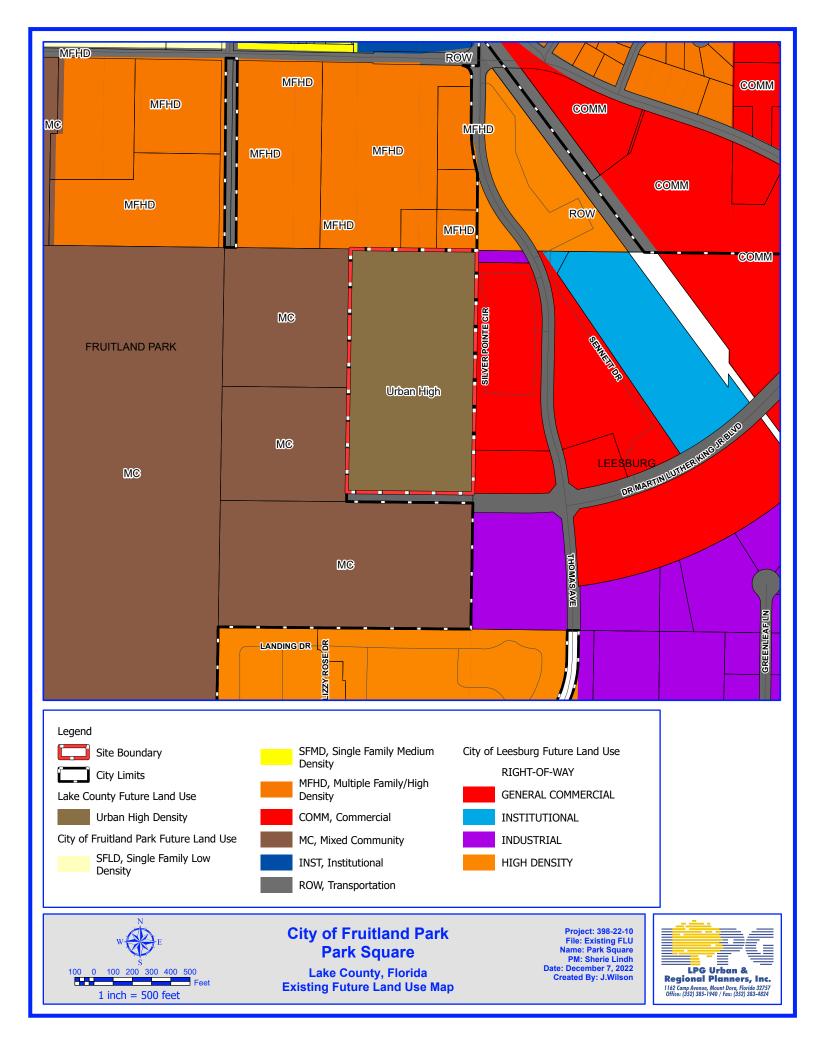

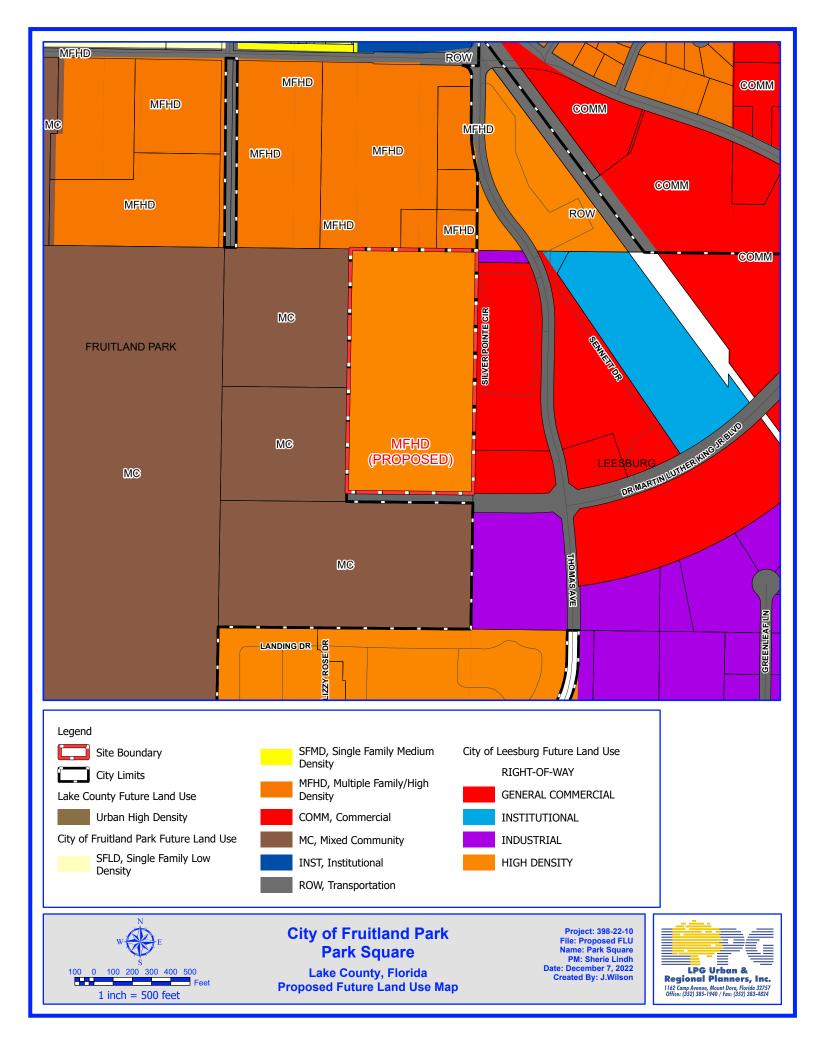

Annexation

The subject site is adjacent to the City limits along the northern and western property boundaries and is eligible for voluntary annexation. The proposed annexation would be considered infill development. The subject site is also within the City's Utility Service Area.

Rezoning

The subject property is currently zoned Agriculture in Lake County and the proposed City zoning is R-10 (minimum lot size for single family of 8,000 square feet with central sewer being utilized, and minimum lot size for multi-family of 6,000 square feet with central sewer). The proposed zoning is compatible with the adjacent lands. The property to the North is zoned R-15, and to the west the property is zoned MUPUD (6 units/acre). The property to the South is City of Leesburg (appears to be City of Leesburg right of way), and to the east the property is zoned C-3.

Small Scale Comp Plan Amendment

For comprehensive plan purposes a maximum development scenario was utilized.

Residential Needs Analysis – The housing element data and analysis indicates the City requires a minimum of 5,460 additional dwelling units to meet the projected need through 2035. The addition of 287 units will assist in meeting this need.

Utility Impact Analysis – The subject site is within the City of Fruitland Park Utility Service Area and central water is available. The LOS for water is 172 gallons per resident per day pursuant to Public Facilities Policy 4-10.1. The estimated population based on US Census data (estimated 2019) of 2.42 person per household is 462. The estimated water usage is 0.079.

The City owns, operates and maintains a central potable water treatment and distribution system. The permitted plant capacity is 2.879 MGD and the permitted consumptive use permit capacity is 1.22 MGD. The City has a current available capacity of .396 mgpd and an analysis was conducted of the proposed amendment based on land use and the City's Level of Service (LOS) standards. The analysis concludes that the proposed amendment will not cause a deficiency and the City will have a remaining available capacity of 0.317 mgpd.

The City of Fruitland Park provides sanitary sewer. The City of Fruitland Park has an agreement with the Town of Lady Lake to treat sewage and the maximum capacity is 500,000 gallons per day (0.5 mgd). The City currently has an available capacity of 430,000 gallons per day (0.43 mgd). The LOS for sanitary sewer is 122 gallons per resident per day pursuant to Public Facilities Policy 4-2.1. The estimated population based on US Census data (estimated 2019) of 2.42 person per household is 462. The estimated sanitary sewer usage is 0.056 (mgd). The analysis concludes that the proposed amendment will not cause a deficiency and the City will have a remaining capacity of 0.374 (mgd).

Environmental Analysis – There are no wetlands or surface waters onsite. Formal surveys for the federally listed sand skink were completed in accordance with USFWS survey protocol in May 2022. A 4-week formal coverboard survey detected a total of forty-seven (47) coverboard with skink tracks within the project site on suitable habitat. The coverboard survey tracks detected determined that 7.43 acres of the subject property contains occupied sand skink habitat and if this area cannot be avoided then mitigation will be required from a USFWS approved Conservation Bank.

There were no known eagle nests observed on the property. A pedestrian survey of the subject property located potentially occupied gopher tortoise burrows. Prior to land clearing and/or construction it is advised that a 100% survey of all potentially suitable gopher tortoise habitat be performed. Prior to development, appropriate regulatory permits will be required.

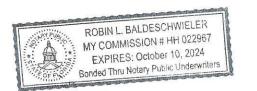

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF FRUITLAND PARK, FLORIDA, REZONING 19.10 +/- ACRES OF PROPERTY FROM LAKE COUNTY AGRICULTURE (A) TO CITY OF FRUITLAND PARK R-10 WITHIN THE CITY LIMITS OF FRUITLAND PARK; GENERALLY LOCATED SOUTH OF URICK STREET AND WEST OF THOMAS AVENUE; DIRECTING THE CITY MANAGER OR DESIGNEE TO HAVE AMENDED THE ZONING MAP OF THE CITY OF FRUITLAND PARK; PROVIDING FOR SEVERABILITY, CONFLICTS AND SCRIVENER'S ERRORS; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a petition has been received from Vishaal Gupta as applicant, on behalf of Kimaya, LLC as Owner, requesting that real property within the city limits of the City of Fruitland Park be rezoned from Lake County A to City Multi-Family Medium Density Residential (R-10) within the City limits of Fruitland Park; and

WHEREAS, the petition bears the signature of all applicable parties; and

WHEREAS, the required notice of the proposed zoning has been properly published; and

WHEREAS, the City Commission reviewed said petition, the recommendations of the Planning and Zoning Board, staff report and any comments, favorable or unfavorable, from the public and surrounding property owners at a public hearing duly advertised;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF FRUITLAND PARK, FLORIDA, AS FOLLOWS:

Section 1: The following described property consisting of approximately $19.10 \pm$ acres generally located South of Urick Street and west of Thomas Avenue as described on Exhibit "A" and depicted as set forth on Exhibit "B" shall hereafter be designated as R-10 "Multi-Family Medium Density Residential" as defined in the Fruitland Park Land Development Regulations.

Section 2: That the City Manager, or designee, is hereby directed to have amended, altered, and implemented the official zoning maps of the City of Fruitland Park, Florida to include said designation consistent with this Ordinance.

Section 3. Severability. If any provision or portion of this Ordinance is declared by any court of competent jurisdiction to be void, unconstitutional, or unenforceable, then all remaining provisions and portions of this Ordinance shall remain in full force and effect.

Section 4. Scrivener's Errors. Scrivener's errors in the legal description may be corrected without a public hearing or at public meeting, by re-recording the original ordinance or a certified copy of the ordinance and attaching the correct legal description.

Section 5. Conflict. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 6. This Ordinance shall become effective immediately upon passage by the City Commission of the City of Fruitland Park.

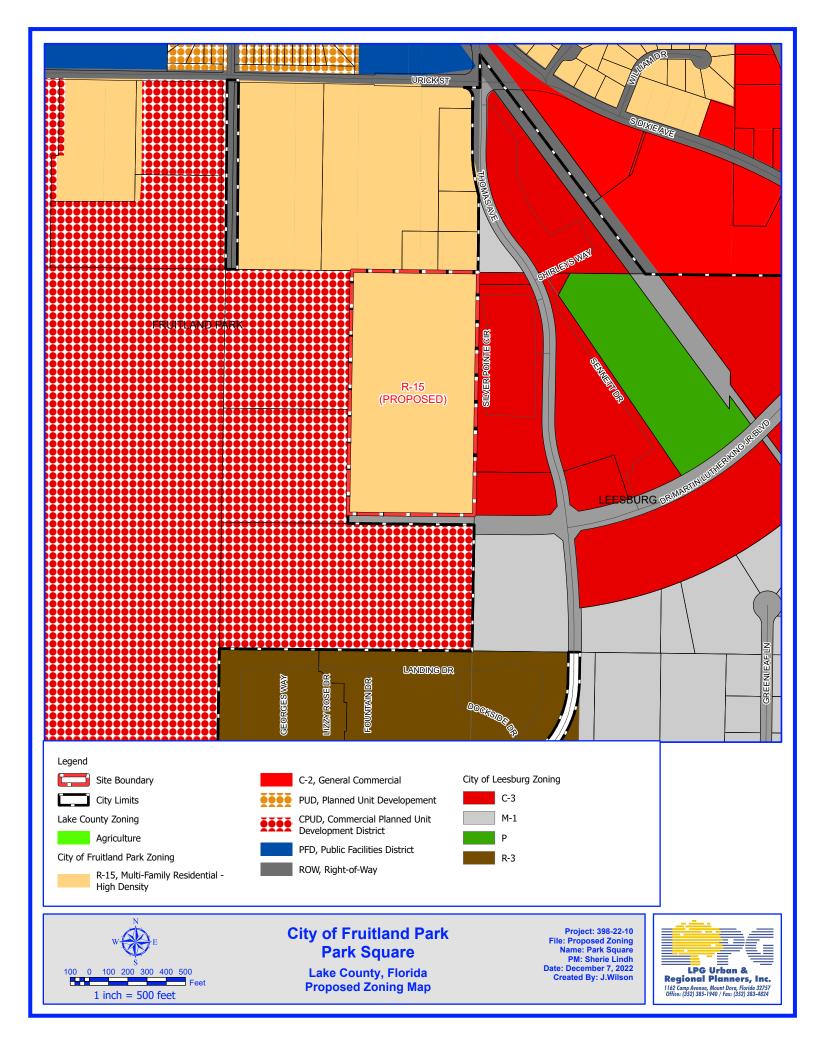

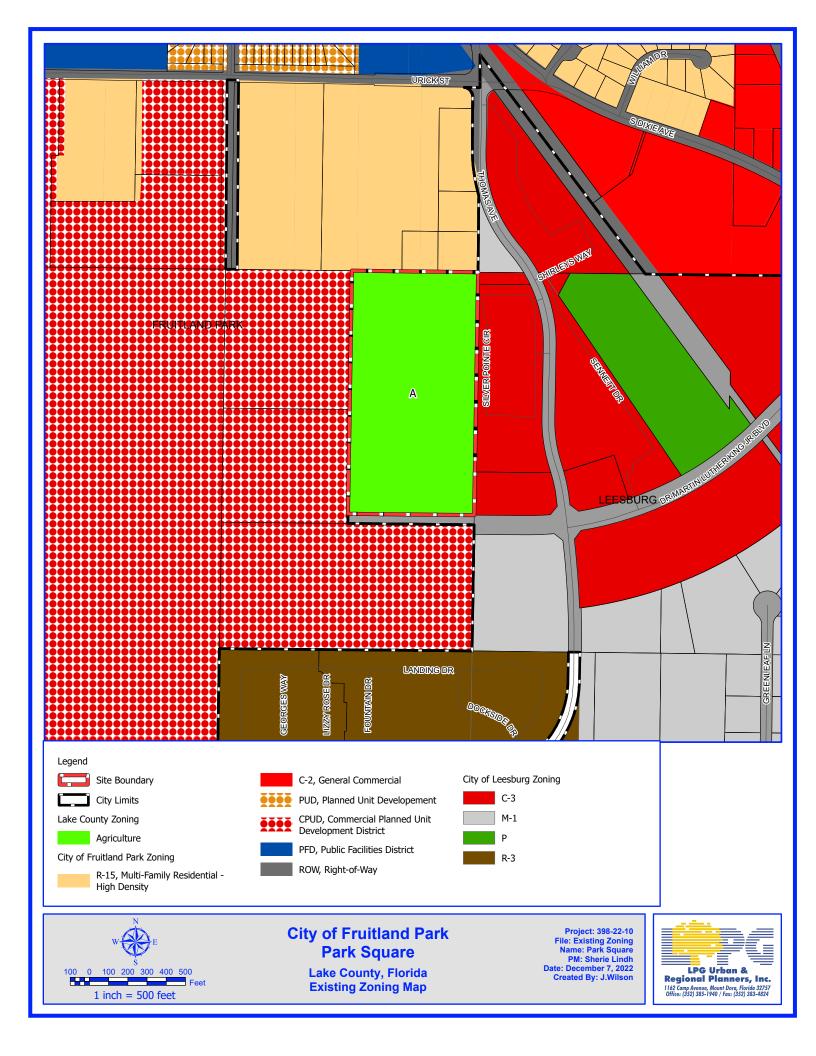

Mayor Cheshire,

I wanted to provide some additional information about the project coming before the City Commission this Thursday.

Our law firm represents Kimaya, LLC for its request for annexation, small-scale comp plan amendment and rezoning on the approximately 19.10 acres south of Urick Street and west of Thomas Avenue. The Property is the easterly adjoining parcel to the approved Mixed-Use PUD, which is approved for up to 700 detached single-family residential units, assisted living facilities up to 220 beds, nursing home use, commercial uses, restaurants, banks, recreation and sports facilities. The parcel immediately to the north of the Property, and within the City of Fruitland Park, is zoned R-15 and entitled for Multi-Family High Density development of up to 15 units/acre.

The Property is currently situated within unincorporated Lake County and is entirely surrounded by the City of Fruitland Park to the North and West and City of Leesburg to the South and East. Following a successful annexation into the City, the Applicant is also requesting a rezoning from (County) Agriculture to (City) R-10 and a FLU designation change from (County) Urban High to (City) Multi-Family Medium Density. Following, discussion with City Staff, the Applicant revised its request from 15 units/acre to 10 units/acre. It is worth noting that the Property's current FLU designation allows for up to 12 units/acre. The applicant's requested FLU designation of (City) Multi-Family Medium Density is a downzoning from its current existing and potential densities.

Annexation of the Property into the City will allow the Applicant to assemble adjoining parcels for a unified, continuous development that will allow for cohesive site circulation, buffering, setbacks, landscaping and other design capabilities in accordance with the specific performance standards of the City's Land Development Code.

The Applicant seeks to develop the Property with a market-rate multi-family product that will service the growth in the area and provide for a range of housing opportunities. Considering recent approvals in the area, the City has specifically contemplated this area for future development of urban-intensity growth. The Intended Use is a Class-A, three-story, multi-family development with market-leading amenities including a club house, pool, lounges, golf simulator, game room, fitness center and yoga room.

City Staff has concluded that the project will assist in meeting the projected housing

needs of the City as outlined in the housing element of the Comprehensive Plan. Importantly, City Staff has also concluded that the SSCPA will decrease the impacts to schools and traffic while not causing deficiencies to the city utilities readily-available to the Property.

For ease of reference, I have attached the Staff Report and conceptual renderings of similar projects. As you will note, the Staff Report concludes that there are ample capacities of all necessary urban services, the proposed land use change is compatible with significant growth in the area, surrounding developments and provide for additional tax base while meeting the projected residential housing needs of the City.
