01. <u>CERTIFIED ELECTION RESULTS</u>

Christopher Cheshire366 (65.71%)Jim Richardson191 (34.29%)

Commissioner Goldberg moved and Commissioner Gunter seconded to certify the election results. The motion carried with all Commissioners voting aye.
