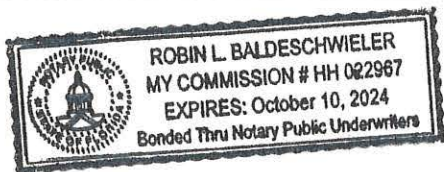

In accordance with the provisions of Subsection 287.057, Florida Statutes and

the City of Fruitland Park Purchasing Procedures, notice is hereby given that one (1) original and two (2) copies of sealed bids for the installation of a stormwater baffle box in the rights-of-way of Mirror Lake Drive and adjacent area must be received by **February 2, 2022, at 3:00 p.m., local time** at Fruitland Park City Hall, 506 West Berckman Street, Fruitland Park, Florida 34731. **A mandatory pre-bid conference will be held January 19, 2022 at 11:00 a.m. at Fruitland Park City Hall.**

Copies of the solicitation package are on file and available by interested firms and may be obtained from Gary La Venia, City Manager, via email at glavenia@fruitlandpark.org or picked up in person at city hall in the city manager's office at 506 W Berckman Street, Fruitland Park, Florida 34731.

Qualified firms desiring consideration shall submit one (1) original and two copies of complete proposal packages, clearly marked "Sealed Bids" to Gary La Venia, City Manager at 506 W Berckman Street, Fruitland Park, Florida 34731 on or before the date and time stipulated above.

The city will not be responsible in the event the U.S. Postal Service or any other courier system fails to deliver any proposal by the deadline date stated above. The city reserves the right to reject any or all submittals and to waive any or all informalities, non-substantial irregularities in items received whenever such rejection is in the best interest of the city or to accept the proposal which best serves the interest of the city.

In accordance with Florida Statutes 287.133(2)(a), any person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for Category Two for a period of thirty-six (36) months from the date of being placed on the convicted vendor list.

All firms are hereby placed on formal notice that neither the City of Fruitland Park Commission, any employees of the city, nor any members of the Professional Services Review Committee are to be lobbied or queried in any manner, either individually or collectively, concerning this project, except that questions may be directed to the city manager and project engineer as stated in the invitation to bid. Any such activities may cause immediate disqualification for this project.

The City of Fruitland Park will select, award and contract with the firm or firms deemed by the city to be the lowest and best responsible qualified bidder responding in accordance with the provisions of F.S. 287.057 and policies of the City of Fruitland Park.
