A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FRUITLAND PARK, FLORIDA, AMENDING THE 2022/2023 FISCAL YEAR BUDGET PURSUANT TO SEC. 6.07 OF THE CITY CHARTER TO INCREASE TRANSFER IN FROM REDEVELOPMENT FUND BALANCE REVENUE BUDGET AND COMMUNITY CENTER IMPROVEMENTS EXPENSE BUDGET; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Fiscal Year 2022-2023 budget of the City of Fruitland Park was adopted on September 22, 2022; and

WHEREAS, the Community Center is utilized by the community for various events, including but not limited to receptions, comedy shows, programs, all of which draws people to the City and within CRA of the City of Fruitland Park; and

WHEREAS, the City Commission desires to improve the Community Center courtyard with a gazebo; and

WHEREAS, it is necessary to increase revenues in the Redevelopment Fund \$54,733 for purchase and installation of a Gazebo; and:


WHEREAS, the City Commission desires to amend the 2022-2023 Fiscal Year budget to increase the Community Center Improvements expense by \$54,733;

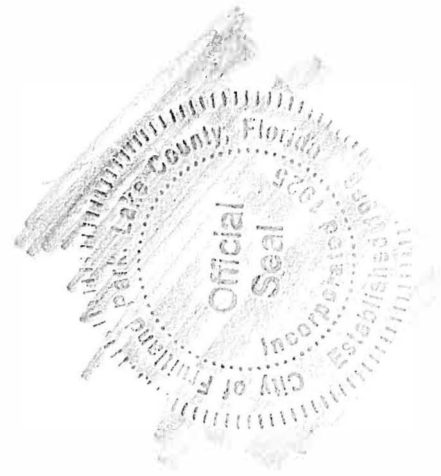
Section 1. The 2022/2023 budget adopted on September 22, 2022 is amended as set forth in Exhibit "A" attached hereto.
