Ms. Geraci-Carver relayed reasons to continue the subject proposed Ordinance 2023-002; referred to the February 8, 2023 ruling from the District Court of Appeal of the State of Florida Fourth District on previously advertised ordinances postponed for adoption to another date, time, and place without being re-advertised does not comply with the statutory notice requirement procedures for adoption of ordinances, and recommended that the LPA continue its actions on the subject item to a future date until the proper advertising requirements are met.
